

The Constitution of The Fulminare Empire

Article I: Government Structure

Section 1: Composition

The Government of The Fulminare Empire is composed of:

1. The Emperor, who serves as Head of State.
2. The Advisor to the Emperor.
3. The Council of the Empire, consisting of one member per province, including the Head of the Council.

All government members, except the Emperor, shall be elected once every month.

Article II: Positions of Government and Powers

Section 1: The Emperor

1. The Emperor is the Head of State of The Fulminare Empire.
 2. The Emperor has the power to declare war on any nation without consultation of the Council.
 3. The Emperor may call a Council meeting at any time.
 4. The Emperor may issue proposals to the Council at any time.
 5. The Emperor is succeeded by an heir of their choosing.

Section 2: The Advisor to the Emperor

1. The Advisor to the Emperor is the default heir to the throne if the Emperor has not chosen one.
 2. The Council must call upon the Advisor to break ties in Council votes.
 3. The Advisor is elected on the first day of every month by popular vote.
 4. If the Advisor cannot complete their term, the Head of Council shall nominate a replacement, subject to approval by both the Council and the Emperor.
 5. The Advisor appoints a new Head of Council if the current Head cannot complete their term.

Section 3: The Head of Council

1. The Head of Council is the Head of Government and Head of State for governmental affairs.
2. The Head of Council is elected on the first day of every month by citizens voting for provincial electors, who then select the candidate. In case of an electoral tie, the popular vote decides the winner.
3. The Head of Council may call Council meetings at their discretion.
4. The Head of Council may propose laws or war to the Council at any time.
5. The Head of Council may veto laws, bills, or war declarations passed by the Council.
6. The Head of Council does not have a vote in the Council unless they hold a provincial seat.
7. The Head of Council serves as Commander-in-Chief of the military.
8. The Head of Council represents The Fulminare Empire both domestically and abroad.
9. If the Head of Council cannot complete their term, the Advisor shall appoint a replacement to serve the remainder of the term.

Section 4: The Council

1. The Council consists of one member from each province, including the Head of Council if they hold a provincial seat.
2. Any Council member may propose laws or war during meetings.
3. The Council shall meet at least once monthly, on the tenth day.
4. Council members are elected by popular vote within their provinces on the first day of every month.
5. The Council can declare war by a three-fifths ($\frac{3}{5}$) majority vote.
6. The Council can override a veto from the Head of Council with a three-fifths ($\frac{3}{5}$) majority.

Article III: Elections

Section 1: Advisor

- The Advisor to the Emperor is elected by popular vote on the first day of every month.

Section 2: Head of Council

- The Head of Council is elected monthly by provincial electors; a popular vote resolves electoral ties.

Section 3: Council Members

- Each province elects their Council member by popular vote on the first day of every month.

Section 4: Voter Requirements

- To vote, citizens must be registered citizens of The Fulminare Empire.

Section 5: Running Requirements

- To run for office, candidates must be registered citizens of The Fulminare Empire.

Article IV: Base Laws

1. All citizens may vote in elections according to the voter requirements.
2. Citizens may only vote for Council members representing their province.
3. Citizens must possess a valid license to own firearms.
4. Theft is illegal and punishable by imprisonment from one month up to life imprisonment.
5. Murder is punishable by death, except when ruled self-defense, which results in dismissal of charges.
6. Any form of assault is punishable by imprisonment ranging from one year to death.
7. A jury of ten people shall be drawn from the district where the crime occurred.
8. Judges shall be elected by their district for ten-year terms, with re-elections every ten years on August 1st.
9. The Emperor is not exempt from murder charges; executions ordered by the Emperor do not constitute murder.
10. Anyone found guilty of zoophilia, child molestation, or rape shall be sentenced to death immediately.
11. No human may legally own another human; violators shall be sentenced to life imprisonment.
12. Treason against The Fulminare Empire shall be punished by death.
